This entry is not, nor will it be, within any withdrawal time relative to the administration of any drug, chemical or feed additive approved by FDA or USDA by the time the animal is officially weighed in by the LVJLS.

The LVJLS reserves the right to condemn and/or disqualify any animal live or slaughtered, found in violation of the use of drugs, chemicals, or feed additives and the exhibitor will forfeit all auction sale and/or premium money if the animal is disqualified.
